1. WELCOME

Kenrick welcomed everyone and thanked them for attendance.

2. PRESENT

As per attendance register

3. CONFIRMATION OF QUORUM & PROXIES

As per the attendance register, it was confirmed that over 70 people were in attendance and quorum had been met and the meeting was declared properly constituted.

4. REPORT FROM INTERIM COMMITTEE

Kenrick Brown gave a summary of what the interim had achieved to date.

The most important was getting the Central SRA properly constituted through consent of the property owners. In addition a grant in the amount of R1 000 000 (one million rand) has been secured from MBDA.
